## **RECOGNIZING AWARENESS MONTHS:**

#### **Lung Cancer Action Week**



Lung Cancer is the number one cancer killer in the United States. In New York, 70% of all lung cancers are diagnosed at a late stage, when it is difficult to treat. We can change that! Lung cancer can be caught early, when it is much more easily treatable, through lung cancer screening.

The New York State Cancer Consortium's <u>Lung Cancer Screening Action Team (LCSAT)</u> is working to save lives through early detection. The LCSAT has developed a <u>website</u> where New Yorkers can find the closest lung cancer screening location and has partnered with <u>GO2 for Lung</u>

<u>Cancer</u> to educate patients and healthcare providers on lung cancer screening. In addition, the LCSAT is working with New York State legislators to help remove barriers to lung cancer screening, like co-pays for follow up testing after lung cancer screening.

The LCSAT received funding from the American Cancer Society to engage underserved communities and raise awareness about lung cancer screening, screening eligibility, and screening locations in the Southern Tier and surrounding areas through a targeted radio awareness campaign. Congratulations!

#### **Lung Cancer Screening Article**



An article co-authored by Susan Opar MD, FAAFP; Heather Dacus, DO, MPH; Mary Reid BSN, MSPH, PhD and Whitney Mendel, MSW, PhD was published in the New York State Association of Family Physicians (NYSAFP) and by the Medical Society of the State of New York (MSSNY) entitled Lung Cancer Screening: Making it the New Norm for Early Detection and Improved Survival. The article describes the state of and evidence for lung cancer screening and concludes that current low lung cancer screening rates highlight the need for improvement in screening awareness and utilization, and when primary care physicians discuss yearly lung cancer screening with their patients, they can raise awareness, offer screening to appropriate patients, address tobacco cessation, and save lives.

#### **National Cancer Survivors Day**



Cancer survivorship encompasses the phase of care that follows the initial diagnosis and treatment of cancer. It includes the physical, emotional, and social challenges that individuals face after the completion of treatment. New York State is home to more than 1.1 million cancer survivors. This number will continue to rise due to advancements in medical technology, early detection methods, improved treatment protocols, and the aging of the population.

Although cancer programs in NYS provide specialized care, including follow-up screenings, rehabilitation services, and management of side effects, most post-treatment care is delivered in the community setting. Primary care physicians play a crucial role in coordinating care and addressing the long-term health needs of survivors. The New York State <a href="Cancer Consortium">Cancer Consortium</a> Survivorship Action <a href="Team">Team</a> has focused on primary care provider education, developing the primary care and advanced practitioner workforce to deliver survivorship care as well as identifying the resources available throughout New York.

#### **Improving Navigation for Cancer Survivors in Rural Communities**



To increase the capacity of primary care practices to address the needs of cancer survivors, The Survivorship Action Team is implementing an educational series for patient navigators who support cancer survivors in rural areas of New York State. Please help promote this educational series to patient navigators in your rural areas.

During three, one-hour, continuing education (CE)-granting sessions (May 8, May 22 and June 5) patient navigators and those in similar roles will increase their capacity to care for cancer survivors and understand the many issues that cancer survivorship may bring. #### **Success Stories Request**



The American Cancer Society Cancer Action Network (ACS CAN) is looking for stories related to recent cuts to cancer research programs and public health funding in support of the ACS-CAN campaign for cancer cures. There is strong interest on Capitol Hill, from the broader advocacy community and from the media, to understand the impact on medical research from these reductions in funding and workforce. Gathering these real-life experiences from cancer patients, researchers, and providers is our opportunity to understand and tell that story to explain the value of federal investments in medical research.

Decades of progress are in jeopardy due to cuts in research funding, staff reductions, and policy shifts at the federal level. The long-standing, broad consensus of support enjoyed by America's premier research institutions is under threat, putting cancer cures and America's leadership in cancer innovation at risk.

What types of stories is ACS CAN looking to elevate?

- Patients impacted by paused, canceled or delayed clinical trials.
- Researchers with NIH or NCI-funded grants/contracts that have been paused, canceled, reduced, or delayed.
  - What work was stopped/curtailed?
  - How much money was rescinded/what fraction of grant/contract?
  - Did this result in wasted money (e.g. sunk costs that won't produce data/information)?
  - Was there loss of data from the public domain? Either retrospective or prospective? What was it?
  - What impact is there to staff?
  - Can you provide vignettes of success stories that your work/research has led to in the past that might not be possible today?
  - Can you provide documentation of the cut/cancellation? E.g. letter, grant/contract number etc.?
- Impacts on training/career pipeline for researchers or providers
  - Are you aware of training grants or early career awards that have been canceled?
  - What was the impact on the trainee or researcher? Will they be able to continue?

#### New Data and Reports:

#### Colorectal Cancer Screening, New York State Adult ages 45-75, 2023

Colorectal cancer is the second leading cause of cancer death in New York State. This report describes that estimates of colorectal cancer screening are significantly lower among Adults who: are 45-54 years, without health insurance, without a regular health care provider, reporting no physical activity in the past 30 days, who currently smoke cigarettes, reporting a primary language other than English and those who are not US Veterans

#### Physical Activity, New York State Adults, 2023

Being physically active benefits adults of all ages, abilities, and diverse lived experiences. Regular physical activity reduces the risk of chronic diseases, such as heart disease, stroke, type 2 diabetes, many types of cancers, and the risk of premature death. This report finds; 73.9% of adults engage in some type of physical activity at least monthly, 58.4% engage in adequate aerobic activity, 41.8% engage in adequate muscle strengthening activity, and 30.8% engage in adequate aerobic and strengthening activities. Any physical activity and adequate physical activity are less prevalent among females, people with lower incomes, people with less education, people living with a disability, and people with obesity.

#### Overweight and obesity, New York Adults, 2023

Obesity risk factors are complex, involving health behaviors, stress, sleep, health conditions, medications, genetics, and environmental factors. This report finds: Approximately 2 out of every 3 adult New Yorkers have either overweight (36.1%) or obesity (28.0%). Disparities in obesity prevalence exist based on age, race and ethnicity, educational attainment, disability status, and place of residence. • Obesity is more prevalent among adults living with a disability (36.4%), and adults living outside of New York City (30.8%).
